

SOFTWARE LICENSE AGREEMENT

License: Subject to the terms and conditions of this License, ARRIS, ("**Licensor**") hereby grants to VAR (the "**Licensee**") the following license to the software ("**Software**") described herein:

(i) **Headend, Transmission and Network Management Software:** a non-exclusive, revocable, non-transferable license to use, with the right to sublicense to Licensee's customers the right to use, the object code of the Software provided by Licensor for use in such VAR and End User cable networks only on or in connection with the Licensor's headend and transmission network system products in which such Software is installed or designed to be used, and only in accordance with the terms and conditions of this License and any other accompanying documentation and supporting content.

(ii) **End-User Products:** a non-exclusive, revocable, non-transferable license to use, with the right to sublicense to Licensee's customers the right to use, the object code of the Software provided by Licensor with its end-user products for use only on or in connection with the Licensor end-user products with which such Software is originally supplied, and only in accordance with the terms and conditions of this License and any other accompanying documentation and supporting content.

No rights are granted under this License other than as expressly stated herein. All Licensor products referred to above are hereinafter referred to as the "**Licensor Equipment**" and all referenced "users" as the "**Users**".

Ownership/Limitations on Use: Licensor and/or its third party vendors retain all right, title and interest in the Software. Licensee expressly acknowledges that title to the Software, including all copyrights and all other intellectual property and proprietary rights of any kind whatsoever in and to the Software and any accompanying documentation, and any modifications thereto, remain with Licensor or its applicable third party vendor. Any such vendors are third party beneficiaries of this License. Licensee may not copy, modify, enhance, reverse-engineer, disassemble, decompile or make any attempt to discover the source code of the Software for any purpose, except that Licensee may make one (1) copy of the Software for back-up purposes only and as permitted by applicable law. If VAR believes that it has a right to exercise any rights under Article 6.1 (b) of the EC Directive on the Legal Protection of Software (Directive 19/250), or any successor or similar law, VAR shall give reasonable notice to ARRIS before attempting to exercise any such right.

Confidentiality: Licensee acknowledges that the Software and any related or accompanying documentation is supplied in confidence and contains valuable trade secrets of Licensor and/or its third party vendors. Licensee agrees to take all appropriate action to protect the confidential and trade secret information contained in the Software and any related or accompanying documentation (the "**Confidential Information**"), which shall be no less than the steps Licensee takes to protect its own confidential and trade secret information. With respect to its own employees, Licensee shall disclose the Confidential Information only to those employees of Licensee that have a reasonable need to use the Software in connection with the purposes of this License.

Proprietary Notices: Licensee shall not remove, alter or modify any proprietary rights notice(s) included on or associated with the Software and any related or accompanying documentation.

Limitations on Transfer: Licensee may not sell, assign, lease, rent, sublicense, give or otherwise transfer, disclose or grant access to the Software or any copy thereof (including copies into RAM) to any other party except as authorized, in writing, by Licensor. Notwithstanding the foregoing, Licensee may transfer Licensee's license rights in and permitted copy(ies) of the Software with the Licensor Equipment to a successor-in-interest to such Licensor Equipment, as long as (x) Licensee makes such successor aware of this License, (y) such successor agrees in writing to be bound by the terms of this License, and (s) such successor is not a direct competitor of Licensor.

Restrictions on Export: Licensee agrees that it will not export or re-export, directly or indirectly, the Software or any Confidential Information, or any products using the Software, to any country for which the United States government, European Union and/or any other applicable countries, or any agency thereof, at the time of export, requires an export license or other governmental approval, without first obtaining such license or approval and the written approval of Licensor. This paragraph shall not be interpreted to enlarge any rights of Licensee to use the Software other than as expressly granted in this License.

Technical Support and Maintenance: Licensor shall be entitled to purchase technical support and maintenance Services as described on the Channel Portal. Technical support is not a substitute for training, installation or Software maintenance Services available for purchase by Licensee from Licensor. New versions of the Software, as opposed to interim maintenance releases, may require additional license fees and/or new terms and conditions. All new versions and maintenance releases delivered to Licensee shall become part of the Software.

Audit Rights: Upon Licensor's request, Licensee shall provide Licensor with a certificate of compliance verifying that Licensee's use of the Software is in compliance with the terms and conditions of this License. Licensor may, at its expense, during regular business hours and in a manner that will not unreasonably interfere with Licensee's business activities, conduct an audit to verify that Licensee's use of the Software complies with the terms and conditions of this License. If the audit reveals an underpayment of any license, maintenance or support fees, Licensee shall promptly pay all amounts owing as well as a reasonable fee for the audit.

Limited Warranty: Licensor warrants to the Licensee only (and not to any subsequent sublicensee or User) that the Software, as delivered, will perform substantially in accordance with Licensor's then-current user manual in all material respects; however, Licensor does not warrant that the Software will meet Licensee's needs, be error-free, or operate without interruption. In order to be valid, all warranty claims must be made by Licensee, in writing (setting forth the details of the warranty claim) not later than ninety (90) calendar days after shipment of the Software by Licensor to Licensee. **LICENSOR MAKES NO WARRANTIES WHATSOEVER REGARDING ANY SOFTWARE AND/OR COMPONENTS OF THE SOFTWARE CREATED OR OWNED BY ANY THIRD PARTY AND HEREBY ASSIGNS TO LICENSEE (TO THE EXTENT PERMITTED UNDER LICENSOR'S AGREEMENTS WITH SUCH THIRD PARTIES) ALL WARRANTIES RELATING TO SUCH SOFTWARE AND/OR COMPONENTS OF THE SOFTWARE. THE FOREGOING WARRANTIES ARE IN LIEU OF ALL OTHER WARRANTIES EXPRESSED, IMPLIED OR STATUTORY RELATING TO THE SOFTWARE AND THE STORAGE MEDIA, INCLUDING, BUT NOT LIMITED TO, IMPLIED WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE AND WARRANTIES OF MERCHANTABILITY OR SATISFACTORY QUALITY EXCEPT THOSE REQUIRED BY LAW.** Any unauthorized use or modification of the Software by Licensee shall void any and all warranties. In addition, to the extent that the Licensee makes any express or implied warranty or indemnity to its customers in respect of the Software or any representation with regard to the Software, it is expressly understood and acknowledged by the Licensee that any such warranty, indemnity and/or representation shall be made solely for the Licensee's account and shall not bind Licensor.

Infringement Actions: Licensee may not bring any infringement action against third parties based on its license rights to the Software without Licensor's prior written consent.

Infringement Claims: Licensor will defend any suit or proceeding brought against Licensee to the extent that such suit or proceeding is based on a claim that the Software provided hereunder constitutes direct infringement of any valid patent, copyright, database rights, mask work, trademark or other intellectual property right and Licensor shall pay all damages awarded by final judgment (from which no appeal may be taken) against Licensee holding that such Software does so infringe, on condition that Licensor (i) is promptly informed and furnished a copy of each communication, notice or other action relating to the alleged infringement, (ii) is given authority, information and assistance necessary to defend or settle such suit or proceeding in such a manner as Licensor shall determine and (iii) is given sole control of the defence, and the sole right to compromise and settle such suit or proceeding. In the event that Licensee is enjoined from using the Software as a result of a claim described in this paragraph, or if Licensor believes such a claim or infringement is likely, Licensor will exert reasonable efforts, at its option and its expense, (a) to procure for Licensee the right to use such Software free of any such liability for

infringement or (b) to replace or modify such Software with a non-infringing substitute otherwise complying substantially with the specifications for such Software, or (c) upon return of the Software, refund the transportation costs and the purchase price, less any applicable depreciation or credit for use, of such Software. If the infringement is alleged prior to completion of delivery of the Software, Licensor has the right to decline to make further shipments without being in breach of contract. A comparable indemnity as that set forth above shall also be deemed to be extended to Licensor by Licensee if any suit or proceeding is brought against Licensor based on a claim that the Software supplied by Licensor in compliance with Licensee's specifications infringe any valid patent, copyright, database rights, mask work, trademark or other intellectual property right. In no event shall Licensor be liable for any: (i) infringement by any third party software; (ii) infringement arising from a combination with, addition to, or modification of the Software after delivery by Licensor; (iii) infringement arising out of compliance with Licensee's specifications; (iv) royalties payable based on a per use basis, or subscriber revenues derived by Licensee therefrom, or any royalty basis, other than a reasonable royalty based upon revenue derived by Licensor from Licensee from sales or license of the infringing Software; (v) royalties payable with respect to, or intellectual property claims related to Intellectual Property Rights associated with compliance with the Moving Picture Experts Group's ("MPEG") Main Profile Video Syntax defined in MPEG-2 specification of Generic Coding of Moving Pictures and Associated Audio: Video (ISO/IEC 13818-2) and the Transport Stream defined in the MPEG-2 Systems specification (ISO/IEC 13818-1) both dated as of November, 1994 ("MPEG-2 Standards") the MPEG-4 Visual and MPEG-4 Systems standards defined in ISO/IEC 14496-2 and ISO/IEC 14496-1, respectively, and the AVC/H.264 Standard, defined in ISO/IEC IS 14496-10; the MPEG HEVC standard (defined in ISO/IEC 23008-2 MPEG-H Part 2 and ITU-T H.265); or VP8 or VP9 by Google, Inc; (vi) royalties payable with respect to, or intellectual property claims related to Intellectual Property Rights associated with compliance with or implementation of standards issued by other public or private standards bodies (including ITU, IEEE, ANSI, ISO/IEC and Cable Labs standards), as well as third party private standards such as 5C Digital Transmission Content Protection, DVB and Dolby Digital Audio; or (vii) infringement arising from any user interface (including but not limited to KreaTVGo and/or KreaTVUI, Rovi guides, Rovi i-Guide, Passport Guide, and DTA guides) or PVR functionality included and/or made available in the Products, which is manufactured and/or supplied by a third party; or (viii) to the extent that such infringement claim could have been avoided by VAR obtaining Content Provider Licenses (as defined herein) under patents or copyright offered to providers of audio, video or data content to end user subscribers by entities that offer licenses for such patents or copyright on reasonable and non-discriminatory bases. For the purposes hereof, "**Content Provider License**" means a license intended solely for use by the entity that provides audio, video or data content to an end user subscriber and does not include any licenses ordinarily imposed on, or available to, manufacturers or distributors of equipment; or (ix) willfulness based upon the actions of the VAR. THE FOREGOING STATES THE SOLE AND EXCLUSIVE LIABILITY OF LICENSOR FOR INFRINGEMENT OR THE LIKE OF PATENTS, TRADEMARKS, COPYRIGHTS, DATABASE RIGHTS, TRADE SECRETS AND OTHER INTELLECTUAL PROPERTY RIGHTS IN CONNECTION WITH THIS LICENSE.

Limitation of Liability: The liability of Licensor to Licensee by way of indemnity or for damages from any cause of action whatsoever with respect to the Software, including any claim of infringement of proprietary rights, shall not exceed the fees paid by Licensee for the Software. Notwithstanding the above, Licensee's exclusive remedy under the limited warranty for defects in the storage media is the replacement of any defective physical media on which the Software is furnished. The liability of Licensor's third party vendors to Licensee by way of indemnity or for damages from any cause of action whatsoever with respect to the Software, including liability for any claim of infringement of proprietary rights, shall not exceed the license fees paid by Licensor to such vendor in connection with Licensor's licensing of the Software to Licensee. Licensor's third party vendors shall not be liable for any general or direct damages. **IN NO EVENT SHALL LICENSOR, ITS AFFILIATES OR ANY THIRD PARTY VENDOR OF LICENSOR BE LIABLE TO LICENSEE OR ANY OTHER PERSON OR ENTITY FOR ANY INDIRECT OR CONSEQUENTIAL LOSS OR DAMAGE (WHETHER SUCH LOSSES OR DAMAGES WERE FORESEEN, FORSEEABLE, KNOWN OR OTHERWISE), SUCH AS LOSS OR PROFIT; LOSS OF ANTICIPATED SAVINGS OR OF THE USE OF MONEY; LOSS OF BUSINESS; LOSS OF GOODWILL; LOSS OF USE OR DOWNTIME; LOSS OF OR CORRUPTION TO DATA OR OTHER INFORMATION; DAMAGES RELATING TO THE PROCUREMENT BY LICENSEE OF ANY SUBSTITUTE PRODUCTS OR SERVICES; OR ANY INDIRECT, CONSEQUENTIAL**

LOSS OR DAMAGE OF ANY OTHER FINANCIAL LOSS EXCEPT THAT ARRIS DOES NOT EXCLUDE OR LIMIT ITS LIABILITY IN RESPECT OF DEATH OR PERSONAL INJURY CAUSED BY THE NEGLIGENCE OF ITS AFFILIATES, OFFICERS, DIRECTORS, EMPLOYEES, AGENTS OR REPRESENTATIVES OR FOR FRAUDULENT MISREPRESENTATION OR SUCH OTHER LIABILITY WHICH CANNOT BE EXCLUDED OR LIMITED BY LAW.

Indemnification by Licensee: Licensee shall indemnify and hold Licensor, its affiliated companies, and Licensor's third party vendors, and all of their officers, directors, shareholders, employees, agents, legal representatives, successors and assigns, harmless from any loss, judgment, damage, cost, expense, claim or liability, as well as reasonable legal fees, related to or arising from (1) Licensee's breach of this License, including without limitation Licensee's confidentiality obligations, (2) Licensee's use of the Software other than as permitted by this License, or (3) Licensee's violation of any applicable law, rule or regulation in connection with Licensee's use of the Software.

Term and Termination: The term of this License shall commence on delivery of the Software and shall continue until the earlier of (a) Licensee's failure to make timely payment of any amounts owed to Licensor under this License or any other agreement, or (ii) Licensee ceases to have physical control and/or possession of the Software and/or the Licensor Equipment to which the Software relates. Notwithstanding the foregoing, this License will terminate, effective immediately (a) if Licensee breaches any provision of this License related to the limitations of use of the Software, and Licensee has not remedied this failure to the reasonable satisfaction of Licensor within five (5) calendar days after Licensor provides written notice to Licensee of same, (b) if Licensee breaches any other provision of this License and fails to remedy such default to the reasonable satisfaction of Licensor within thirty (30) calendar days after Licensor provides written notice to Licensee of same, (c) if Licensee breaches its obligations of confidentiality under this License or any other agreement with Licensor and Licensee has not immediately remedied the breach to the reasonable satisfaction of Licensor, (d) upon the filing of a voluntary petition in bankruptcy or an assignment for the benefit of creditors by Licensee, or the filing against Licensee of an involuntary petition in bankruptcy unless such petition is dismissed within ninety (90) calendar days, (e) if Licensee prosecutes or assists in the prosecution of any claim, demand, action or cause of action against Licensor, Licensor's affiliates, and/or any of their respective successors, assigns, directors, officers, employees or customers for, on account of, relating to any intellectual property of Licensor or any of its affiliates. Licensee acknowledges that subsection (e) of this paragraph is a condition of this License and that Licensor is relying upon it in granting the license hereunder to Licensee. Upon termination of this Agreement, Licensee shall cease using the Software, delete all copies of the Software from the Licensor Equipment and return to Licensor all papers and materials in respect of the Software, including the Confidential Information.

Equitable Relief: Licensee agrees that in the event of a breach of or threatened breach by the Licensee (including the Users) of the provisions of this License, Licensor may have no adequate remedy in money or damages and, accordingly, will be entitled to seek injunctive and other equitable relief for such breach in addition to and not in limitation of any other legal or equitable remedies to which it would otherwise be entitled.

Governing Law/Jurisdiction: The validity, construction and performance of this Agreement and the transactions to which it relates shall be governed by the laws of England and Wales, without regard to conflict of laws principles and excluding the provisions of the United Nations Convention on Contracts for the International Sale of Goods, concluded at Vienna, on April 11th 1980, as amended and as may be amended further from time to time. All actions and claims arising under this License shall be subject to the exclusive jurisdiction of the English courts. Licensee agrees that in any action brought by Licensor Licensee shall not challenge such action on jurisdictional grounds. Nothing herein shall be construed as limiting Licensor's right to maintain an action, claim or legal proceeding, or to enforce any judgment, in a court of any jurisdiction in which Licensee or any assets of Licensee may be located and Licensee hereby agrees to submit to the jurisdiction of such courts.

U.S. Government Licensees: U.S. Government Licensees expressly agree that the Software is subject to Restricted Rights as provided under the provisions set forth in subparagraph (c)(1)(ii)

of clause 252.227-7013 of the Department of Defense Federal Acquisition Regulations Supplement (DFARS), or similar acquisition regulations of other U.S. government organisations.

Complete Agreement: Unless there is a separate written agreement between the parties covering the subject matter of this Agreement, this License constitutes the entire understanding between the parties relating to the subject matter hereof. No modification or amendment of this License shall be effective unless in writing and signed by duly authorized representatives of both of the parties hereto, or Licensor notifies Licensee of a modification or amendment and Licensee manifests its assent by continued use of the Software subsequent to such notice.

Miscellaneous: This License shall be binding on and inure to the benefit of the respective successors, permitted assigns, and legal representatives of the parties. If any provision of this License is adjudicated to be invalid or unenforceable by a court of competent jurisdiction, such invalidity or unenforceability shall not affect any other provision of this License which can be given effect without the invalid or unenforceable provision or application, and to this end, the provisions of this License shall be severable. No waiver or forbearance by a party of any violations or non-performance by the other party of any of its obligations, contracts, or covenants hereunder shall be deemed to be a waiver or forbearance of any subsequent violation or non-performance of the same or any other covenant, contract or obligation. Licensee shall pay all sales, use, value added or other taxes, federal, state, foreign, local or otherwise, however designated, which are levied or imposed by reason of the transaction contemplated by this License (with the exception of any income tax on Licensor). All obligations of Licensee with respect to confidentiality, limitations of liability and warranties, indemnification, injunctive relief, governing law, and survival shall survive termination of the License. This License is for the sole and exclusive benefit of the parties and does not create a contractual relationship with, or create any rights in favour of any third party except that ARRIS' Affiliates may enforce any provision of this License.
